#### 5. Review of 2016 State Championships

Lindeman

- Over 12,000 people attend the championships. Most in 3 years.
- Next year's championships will take place in Ft. Myers at Hammond Stadium
- January 30th first practice date
- Everything was pushed back two weeks to help with overlap
- Tournament dates:

District tournament – May 1<sup>st</sup>- May 5<sup>th</sup>

State Tournament – May 24<sup>th</sup> – 27<sup>th</sup>

### 6. FACA Recommendations

Yancey

- 25 games and 2 tournaments
- Time limit on Friday and not on Saturday
- 1 game a week in the playoffs
- Best 2 out of 3 in regionals
  - Travel expenses and weather can be an issue
  - Not enough rest for pitchers
  - Number 2-3 pitchers might not be getting enough innings. Can affect your team.
- Carter caps delivery system (Pitching)
- Regular season champion automatically qualifies for district final

### 7. Compliance Update

**Compliance Staff** 

- Update on house bill 729
- 2017-18, open enrollment rule will start
  - Seats must be available in order to take kid(s) in.
  - Military families will have priority
- Starting July 1<sup>st</sup>, if the student is attending school and meet all the eligibility requirements, then the student can participate.
- If student participated in a sport(s), then they will not be eligible to participate in sports in another school during the school year
  - There are exceptions: military families, families moved, death of guardians
- Penalties in place for any possible recruiting

- Salary deductions
- Fines
- No camps during the school year
  - Must be ran by a third-party organization and have no affiliation to the school
- Social media
  - No recruiting through social media
  - No endorsements of parent(s) recruiting posts
  - No posts that can potentially entice students to attend certain school(s)
- Stay in touch with your ADs with everything you're doing with your team
- 8. <u>Old Business</u> Committee
- Coaches ejection/limit in dugout (Restricting to the dugout)
  - Official warning before ejecting coaches. Denied 13-0. NFHS rule about warnings, adopted in Florida.
- Addition to the mercy rule
  - 13-0 approved in committee and endorsed by ADs.
  - 10 runs after 5 innings
  - Motion to vote, 15 runs after 4 innings.
  - Motion to vote by (First, Bruce Aven: Second by Dale Hall; 6-0 will now be brought up to ADs.
- Ending procedures for games
  - Game can be called after 5 complete innings due to weather.
  - Coaches want playoff games to be played to completions, regardless of weather and score.
    - Motion to vote by Bruce Aven: First by Gil Morales Second by Tom Woodley; Vote approved 6-0
- 9. New Business
- Pitching Stance
  - Called different by different associations (misinterpretations)
  - Should follow college rules (hybrid stance)
  - Motion to vote by First Landy Faedo; Second Bruce Aven: 6-0
- -Use of low seam baseballs
  - Use of the same balls all the way through the playoffs (Wilson low seam)
  - Use of any ball for regular season
  - Motion to vote by Dale Hall Second Tom Woodley; Vote 6-0
- Eliminating JV 2 hour time rule

- Players work all week and deserve to play the full game
- If there is no varsity game to follow, game should be played until completion
- Vote to modify to 2.5 hours to a standalone game instead of 2
- Motion to vote; First by Erik Entrekin Second Bruce Aven; Vote 6-0
- Eliminating coin flip to determine district seeding
  - This is a policy and the toe committee did not vote on the item.
- Pre-game stretching
  - Teams should be stretching on their side of the field, by the foul line
  - Motion to vote by Tom Woodley and second by Bruce Aven: 6-0
- Baseball regional playoff qualifiers
  - The committee decided not to vote on the item
- 10 hitters for JV games
  - It will help with the development of players
  - Most coaches do not have a problem
  - Motion to vote by Gil Morales and second by Eric Entrekin: 6-0
- Addition to mercy rule
  - 15 runs after 4 innings
  - Was discussed at the beginning of the meeting. See old business
  - Motion to vote by Erik Entrekin and second by Tom Woodley: 6-0
- Live balk rule
  - Penalize the defense, not the offense
  - Motion to vote by Bruce Aven and Second by Bruce Aven: 6-0
- Discussion items:
  - Protested games
    - o 10 inning pitch rule
  - 25 games and 2 tournaments
    - Tournaments would not count towards the 25 game limit
    - o Teams missing out on games due to tournament games counting
    - Spring break tournaments
    - Action item for next year
